

RAVE MINISTRIES, INC PRIVACY POLICY

Last updated: Oct. 1, 2009

This policy describes Rave Ministries, Inc.'s (referred to in this policy as "Rave Ministries," "we," or "us") use and sharing of personally identifiable information ("PII"), that Members voluntarily provide to Rave Ministries when they register. This privacy policy applies to any Rave Ministries-branded URL (the "Rave Ministries Web Site") and related electronic communications with you. Capitalized terms used in this privacy policy that are not otherwise defined in this privacy policy shall have the meanings ascribed to them in the Rave Ministries Terms of Use agreement (the "Agreement"), which is available on the Rave Ministries Web Site.

This privacy policy is applicable only to the Rave Ministries Web Site and does not apply to any third party web sites or to other companies or persons. The Rave Ministries Web Site may contain links to, and media and other content from, other sites. In addition, such third-party media and content may also contain external links. Because of the dynamic media capabilities of the Rave Ministries Web Site, it may not be clear to you which links are embedded in the Rave Ministries Web Site and which are embedded in third-party media and/or content. Although Rave Ministries requires our business partners and advertisers to adopt privacy policies similar to this privacy policy with respect to any information collected on the Rave Ministries Web Site, Rave Ministries cannot and does not guarantee the privacy policies and practices of any third party. Rave Ministries does not control, operate, or endorse any information, products, or services of any third-party web sites that may be reached through links from the Rave Ministries Web Site. The use of any personal information provided by you to such a third party will be governed by that party's privacy policy. If you are unsure whether a web site is controlled, affiliated, or managed by Rave Ministries, you should review the privacy policy at each linked web site to determine how that site treats your personal information.

RAVE MINISTRIES MAY CHANGE THIS PRIVACY POLICY FROM TIME TO TIME. THE REVISED POLICY WILL BE POSTED ON THE RAVE MINISTRIES WEB SITE. YOU SHOULD CHECK THIS PAGE PERIODICALLY FOR CHANGES. Your continued use of the Rave Ministries Web site after Rave Ministries posts a revised Privacy Policy signifies your acceptance of the revised Privacy Policy.

This privacy policy does not apply to information disclosed to or obtained by Rave Ministries other than that through the Rave Ministries Web Site.

Our Policy Towards Children

The Rave Ministries Web Site is a general audience site, and Rave Ministries does not permit children under 13 to create a Rave Ministries membership or a Profile without the consent of a parent or legal guardian, nor does Rave Ministries knowingly collect PII from children under 13 years of age. Information We Collect

Rave Ministries does not collect PII about you through the Rave Ministries Web Site unless you provide us that information voluntarily. Visitors may use portions of the Rave Ministries Web Site without registering or providing PII. To register as a Member and create a Profile on the Rave Ministries Web Site, we may require you to provide certain PII as well as to create a user name and to provide a password.

Rave Ministries Members may also choose to provide or store non-PII information about themselves in their Profiles that may be viewed by other Members and Visitors. The information in a Member's profile is provided at his or her sole discretion.

Rave Ministries may collect other non-PII information from Visitors and Members including without limitation information relating to the frequency and length of visits, which pages are viewed during a visit, the links to other web sites invoked during a visit, the domain name and IP address from which visitors

are connecting, and the type and version of web browser (“Aggregate Data”). In addition, Rave Ministries may take your personal information and create anonymized information by excluding information (such as your user name) that makes it personally identifiable to you (“Anonymized Data”).

Rave Ministries may compile logs of IP addresses of Visitors and Members for administrative and analytical purposes. Rave Ministries does not routinely collect any PII through its gathering of IP addresses or the locations of computers on the Internet, but in cases of suspected violation of the Agreement or service problems, Rave Ministries may use an IP address along with other PII to enforce the Agreement and/or to protect or troubleshoot the Rave Ministries Web Site. Except as otherwise provided in this privacy policy or the Agreement, Rave Ministries will not share with third parties any PII associated with IP addresses.

We may record information about your usage, such as when and how you use the Rave Ministries Web Site, Members with whom you exchange Messages, and the frequency and size of data transfers, as well as information you display on a Profile. If you are logged in, we may associate that information with your Membership. We may use clear GIFs (also called web beacons) in HTML-based e-mails sent to our users to track which e-mails are opened by recipients.

Rave Ministries also may use cookies on the Rave Ministries Web Site. Cookies are small text files that are placed on your computer's hard drive by our servers to identify your computer to our servers. Except as otherwise provided in this privacy policy or the Agreement, no PII stored in the Rave Ministries cookies will be shared with outside companies for any purpose without your permission. You can disable cookies or otherwise manage them through tools provided with your browser software and with third-party software packages, or not use the features that require cookies, but if you choose to reject our cookies, some areas of the Rave Ministries Web Site may not function properly.

We and our advertisers may use third-party companies to serve ads when you visit the Rave Ministries Web Site. These third-party ad-serving companies may also place cookies on your computer. Sometimes these cookies may be used to provide targeted advertising to you. These advertising companies may also use Web beacons to help manage and optimize our online advertising.

Rave Ministries may use the information it collects, including without limitation your personal information, Aggregate Data, and Anonymized Data, for any lawful purpose that does not involve disclosure in contravention of this privacy policy, including without limitation to provide you with access to your Membership and Profile, to provide you with services you have requested, to enhance and improve our services, to provide customized advertising to you, to conduct research, to determine your geographic location or other demographic information about you, and to analyze usage patterns.

Rave Ministries reserves the right to send you certain communications relating to your Membership or the Rave Ministries Web Site such as service announcements and administrative messages. You cannot opt out of these messages.

Information We Share

Unless we have your consent, it is our policy not to sell, rent, license, or provide personal information about you to any unaffiliated third party (except other users of the Rave Ministries Web Site viewing your Profile information or otherwise using the Rave Ministries Web Site's normal functionality) unless we are required to do so by judicial, legal, or other government proceedings or we have a duty to do so. In the course of our business, we may share some or all of the information described above among our affiliates.

Rave Ministries may share PII with other Members to enable the normal course of functionality of the Rave Ministries Web Site, with third-party service providers who help us in the operation of the Rave Ministries Web Site and who have agreed to maintain the confidentiality of the data, and with other third parties to offer products or services that may complement your relationship with us. Rave Ministries also may access or disclose PII or non-PII Profile information without providing you notice or a choice in order to protect or defend the legal rights or property of Rave Ministries, our affiliates, or their employees,

agents and contractors (including enforcement of our agreements); to protect the safety and security of users of the Rave Ministries Web Site or members of the public, including acting in urgent circumstances; to protect against fraud or for risk management purposes; or to comply with the law or legal process. In addition, if Rave Ministries sells all or part of its business or makes a sale or transfer of all or a material part of its assets or is otherwise involved in a merger or transfer of all or a material part of its business, Rave Ministries may transfer your PII to the party or parties involved in the transaction as part of that transaction.

You can use the Rave Ministries Web Site to send or receive Messages from other Members. To the extent that your Messages include PII, such information may be saved on our server(s) and may be disclosed to third parties, including without limitation law enforcement agencies, courts, and other authorities, as more fully set forth in the Agreement.

Information You Disclose to Others through the Rave Ministries Web Site

Any personal information or content that you voluntarily disclose online (in your Profile, in Discussions and in and Testimonials) becomes available to other Members and/or to the general public and can be collected and used by others. When you create a Membership and Profile, some information about your Membership and your activity may be provided to other Members and Visitors, such as the date you created your Profile, the date you last logged in, and whether you are presently online.

Non-U.S. Users

Rave Ministries is hosted and operated entirely in the United States and is subject to United States law. Any personal information that you provide to Rave Ministries or through the Rave Ministries Web Site is being provided solely in the United States and will be hosted on United States servers. If you are accessing the Rave Ministries Web Site from outside the United States, please be advised that United States law may not offer the same privacy protections as the law of your jurisdiction.
